
Seventy-five years of Independence ought to have been more than enough time to ensure that the last man in the country lives with dignity.

The National Legal Services Authority and the Meghalaya State Legal Services Authority, therefore discharge a crucial responsibility in ensuring, as their Motto says 'Access to Justice for All'.

I am extremely happy that, the MSLSA is publishing its Seventh Edition of 'NEW LIGHT' Newsletter, which will chronicle this Institution's achievements, activities and other programmes in the field of legal aid, especially taking into account, the period of the COVID pandemic in the State.

As the Executive Chairman, during the year 2019 and part of 2020, it is my privilege to highlight a few of the many programmes that were conducted state wide. It is noteworthy to mention that, the MSLSA during the period of the pandemic had actively provided legal services and aid to thousands of beneficiaries, in the form of distribution of over 5000 PPE (Personal Protective Equipment), distribution of food commodities to over 837 families with the support of other societies such as Ramakrishna Mission, Sohra.

Assistance during natural disasters, like floods, landslides etc., was rendered by the State Authority to the affected population by visiting the sites and co-ordinating the relief, including restoration and repair along with the concerned government departments. Apart from these activities, training/orientation programmes for District Legal Services Authorities, Para-Legal Volunteers, Legal Aid Counsels, Police Personnel, Headmen, etc., covering various topics such as PLV schemes, victim compensation, POCSO Act, NDPS Act, Early Access to Justice at Pre-arrest, Arrest and Remand stage were held.

Various other legal awareness and sensitization programmes for students, children, young people, police, NGOs, government employees/departments, senior citizens, specially abled persons, daily wage, domestic workers, jail inmates, transgenders, sex workers, drug users, PL HIV's were organised on a wide range of topics covering NALSA schemes, POCSO Act, Juvenile Justice Act and other relevant laws concerning child and women rights. The programmes on legal awareness were organized and held in places and on media platforms that had the maximum visibility, to ensure that an impact was created, and the public made aware.

Together with the High Court Legal Services Committee and the District Legal Services Authorities, MSLSA in the year 2019-2020, was able to render legal aid services to around 5940 beneficiaries, and the legal awareness and outreach programmes benefitted more than 1,84,063 persons. National Lok Adalats were conducted, and Mediation cases referred by the Courts to the Mediation Centre were also taken up. The Victim Compensation Scheme, was also actively implemented and in the relevant period that is, 2019-2020 (April-March), a total compensation amount of Rs.74,3500 (Rupees Seventy-Four Lakhs Three Thousand Five Hundred) was disbursed and for the period 2020-2021, 70,00000(Seventy Lakhs) was awarded.

By this publication, the public and other stakeholders, will be informed about the initiatives and activities, that have been undertaken by the MSLSA, and I am certain will also create an awareness about the Legal Services Movement.

In conclusion, I would like to record my deep appreciation to all who were involved in conducting the programmes and other activities, especially during the time of the pandemic. I am confident, that the MSLSA will not only continue its good work, but will increase its footprint, in providing access to justice to the people of the State of Meghalaya.

Article 39A of the Constitution of India ensures free legal aid and the State has enacted the Legal Services Authority Act 1987 to ensure that the Directive Principles of State Policy is implemented in letter and in spirit to ensure that justice is secured by all citizens on basis of equal opportunity.

The Covid- 19 pandemic has put us all through unprecedented times and 'New Light' is here to encapsulate the significant activities and achievement of Legal Services Authorities both State and District and the paradigm shift during this difficult times. During the pandemic, I am delighted to share the sincere effort of all associated with legal services the assistance rendered in providing legal services during the pandemic, during the natural disaster/calamities. Various legal awareness programmes were conducted through the means of electronic media, webinars/video conferencing in Schools/Colleges, orientation programmes for Headmen on Para Legal Volunteers, Senior Police Officer's & Secretary, DLSAs on Early Access to Justice on Pre-Arrest, Arrest and Remand Stage among other topics.

In the implementation of the various schemes under NALSA, the state legal services authority along with the District Legal Services Authority of all the districts were able to render assistance to victims of natural disaster under NALSA (Legal Services to Disaster Victims through Legal Services Authorities) Scheme, 2010, provide a forum for the marginalised to claim entitled benefits under NALSA (Legal Services to the Workers in the Unorganized Sector) Scheme, 2015, mobilized the DLSAs to work with JJBs, DCPOs under the NALSA (Child Friendly Legal Services to Children and their Protection) Scheme, 2015, provide awareness and also special care including vaccination against the Corona Virus under NALSA (Legal Services to the Mentally III and Mentally Disabled Persons) Scheme, 2015. Regular awareness are conducted on schemes like MGNREGS, NRLM under the NALSA (Effective Implementation of Poverty Alleviation Schemes) Scheme, 2015 and the Police and public have been sensitized on the various provisions of the NDPS Act as per the NALSA (Legal Services to the Victims of Drug Abuse and the Eradication of the Drug Menace) Scheme, 2015. Para Legal Volunteers have

been instrumental in providing aid to senior citizens as provided under the NALSA (Legal Services to Senior Citizens) Scheme, 2016.

Further, I am honoured to inform that the State Legal Services Authority and District Legal Services Authority in collaboration with various Department of the Government, NGOs and well wishers worked endlessly to alleviate the suffering of people in the marginalized society and played a decisive role in the battle against the pandemic an ensure protection of right of citizens.

It is also a matter of immense pride that the Legal Services Institutions is able to provide assistance to the victims and/or their dependent under the Meghalaya Victim Compensation Scheme and National Victim Compensation Scheme framed under Section 357A CrPC. An amount of Rs. 68,35,000/- (Rupees Sixty Eight lakhs and thirty five thuosand onle) has been disbursed under the said schemes.

It is a pleasure to compile and collate all the landmarks, milestones and activities the Legal Services Institution achieved during the period of January, 2019 to November, 2020. Some of the highlights during this period were the establishment of Front Office of the District Legal Services Authority, East Khasi Hills District, Shillong, Launching of Education Campaign on "Opening Doors for Education to Children", Holding of Regional Consultation of Member Secretaries, State Legal Services Authority and Secretaries of District Legal Services Authority of North Eastern States.

The Meghalaya State Legal Services Authority under the guidance of National Legal Services Authority and Hon'ble High Court of Meghalaya has set a milestone in establishing District Legal Services Authority in all Districts manned by Judicial Officers and establishing Network of Legal Aid Counsels and Para Legal Volunteers to ensure justice is accessible to all.

It is a humbling experience to be part of the editorial process of the Newsletter and to witness the growth of the Legal Services Institutions in the State. Law and the Legal Services Institution must be dynamic and change with the change in the definition of truth.

he Legal Services Authorities Act, 1987 was enacted by the Parliament to give effect to Article 39 A of the Constitution of India which guarantees free and competent legal services to the weaker sections of the society to ensure that they are not denied access to justice by reason of economic or other disability. As provided under Section 6 of the Legal Services Authorities Act, 1987, the Government of Meghalaya has constituted the Meghalaya State Legal Services Authority (MSLSA) in July 1998. In line with this, the Meghalaya State Legal Services Authority Rules, 1998 and the Meghalaya State Legal Services Authority Regulations, 2000 were framed. The office of the MSLSA is presently housed in the annexed building of the Additional Secretariat, Shillong. The Member Secretary and other officers and staff function under the direct supervision and guidance of the Hon'ble Executive Chairman, to fulfill an onerous duty to ensure that the Legal Aid Programmes and Schemes are implemented in its letter and spirit in the State. In order to ensure that the objectives of the Act are translated into reality, and that the constitutional guarantees are fulfilled to the people of the State, the MSLSA has devised a comprehensive legal services programme in the form of the State Action Plan. Efforts have been made when framing the programmes/activities to ensure that they adapt to local situations so that they can effectively address the problems faced by the people in the State. It is expected that these activities will be carried out in letter and spirit and that the benefits actually reach the targeted sections of society leading us towards the goal of "Access to Justice for All".

LAUNCHING OF THE CAMPAIGN ON "OPENING DOORS FOR EDUCATION TO CHILDREN"

11th December, 2019 at the Conference Hall, High Court of Meghalaya

His Lordship, Hon'ble Mr. Justice H.S. Thangkhiew expresses pleasure to announce that the Meghalaya State Legal Services Authority under the patronage of Hon'ble Chief Justice is launching the campaign called "Opening Doors for Education to Children". The objective of this campaign is to enable access of education and learning to all the children of the State of Meghalaya who are deprived of the same or who have dropped out of school. This campaign tries to encompass all sections of society irrespective of gender, caste, disabilities or abilities.

His Lordship emphasized that the campaign "Opening Doors for Education to Children" is a programme for securing the Right to Education of Free and Compulsory Education for children up to the age of 14 years which has been narrated as a Fundamental Right to them by Article 21 of the Constitution of India. Clause A of Article 21A read with Article 51A (k) of the Constitution of India casts a Fundamental Duty upon every parent and guardian to provide opportunities to enable their Children to explore possibilities for Education between the age of 6 and 14 years. It is in this spirit that the Parliament has enacted the Right of Children to Free and Compulsory Education way back in 2009. NALSA also set up a scheme "Child Friendly Legal Services to Children and their Protection Scheme, 2015 for the benefit of children.

Children are the greatest assets that a nation possesses, their wellbeing and growth is an important indicator of social being. 1/3rd of the population of the country unfortunately are not admitted in the schools.

It was therefore felt necessary that all school dropouts be brought back to school and therefore decision was made to launch this programme, and try to re-admit and ensure that they are provided with all the amenities.

The Meghalaya State Legal Services Authority with the help of full time Secretaries of all the District Legal Services Authorities and PLVs will play a role of a catalyst to help the State Government, agencies in attending the schools.

The Hon'ble Chief Minister of Meghalaya expressed his gratitude to the Hon'ble Chief Justice, High Court of Meghalaya for inviting him to attend the programme as a Chief Guest.

In his speech, he admitted that Education in Meghalaya is something that has been a great challenge. Emphasis has been given by the Government. It was announced that the State Government has developed an Education policy. This policy is to be the guiding document on how to go ahead with education. Today the Government is facing challenge almost close to 11 lakhs children who are

below the age of 14 and only about 9 lakhs students who go to school. There are reportedly about 14 thousand Schools in the State and almost close to 16 thousand Teachers. The difficulty that the Government is facing is providing salary to teachers. The Government is spending almost close to 2500 crores on education. The Government is contemplating to do more despite limitations. In the primary education sector, there is a dropout rate of 70 percent. In the upper primary sector, there is a drop out of almost close to 9.5 percent and when it comes to the secondary level there is a dropout rate of 19.3 percent. There are reportedly almost 4 thousand schools which have 3 teachers and have less than 10 students, about 20-25 schools which have 3 teachers and zero students for the past 3 years. The Government's focus is to ensure the balance between such large number of teacher and schools and yet having large number of drop out.

The Government was contemplating on the program called the Meghalaya Outcome and Transformation in health, nutrition, education and rural development. This program is going to center around the mothers linking details, right from the mother's pregnancy, no. of children she has, the nutrition of every child, whether the child is being immunized or not and many other child related details.

The goal being the health of the mother, the child and the growth of the child in a positive environment. The onus being equally shared by health, education and the social welfare Department that needs to streamline all these departments and make sure that the benefit which is meant for the people reach to them on time.


